- If you are not the brand owner, you must have written permission to enter the Masters Series
- Silver, Gold and Master will be awarded in each category
- The Gold and Master winners from each category will then be judged for the overall title of Grand Rum Master 2014
- Awards will be given at the discretion of the judges
- The chairman's decision is final
